

Assessment Fees

Sec 34-1 COB Code Qualifying Fees: for Candidates

All candidates for the office of Mayor/Commissioner or for the office of member of the City Commission of the City shall pay a fee at the time of filing.

The fee must be paid with a check from the campaign account payable to: City of Belleview

- a) \$25.00 CITY QUALIFYING FEE – COB Ordinance 2003-16
- b) \$36.00 STATE ELECTION ASSESSMENT FEE WHICH IS 1% OF THE ELECTED OFFICIALS ANNUAL SALARY (F.S. 99.093)

ORDINANCE 2003-16

AN ORDINANCE AMENDING CHAPTER 34, SECTION 34-1. “QUALIFYING FEE FOR CANDIDATES.” OF THE CODE OF ORDINANCES OF THE CITY OF BELLEVIEW; PROVIDING FOR FEES TO BE SET FORTH IN A COMPREHENSIVE SCHEDULE OF FEES; PROVIDING FOR AMENDMENT BY RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission has determined that it is in the best interest of the Citizens of the City of Belleview to establish qualifying fees for candidates; and

WHEREAS, the City Commission has determined that said qualifying fees should be included in a comprehensive schedule of fees.

NOW THEREFORE, BE IT ORDAINED by the City Commission of the City of Belleview, Florida that the following qualifying fees are hereby adopted regarding Chapter 34, Elections, to wit:

Qualifying Fees:

Mayor/Commissioner	\$25.00
Commissioner	\$25.00

The above-established fees shall be set forth in Appendix “B”, Table 1 “Administrative Fees” of the Code of Ordinances of the City of Belleview.

BE IT FURTHER ORDAINED by the City Commission of the City of Belleview, Florida that “Chapter 34, Sec. 34-1. “Qualifying Fee For Candidates.” of the Code of Ordinances of the City of Belleview, is hereby amended as follows:

Section 1. All candidates for the office of mayor/commissioner or for the office of member of the city commission of the City shall pay a fee at the time of filing, in the amount set forth in Appendix “B” Table 1. “Administrative Fees”.

Section 2. The rates and fees as established herein may be amended from time to time as is appropriate by resolution of the City Commission.

BE IT FURTHER ORDAINED by the City Commission of the City of Belleview, Florida that Sections of this ordinance may be renumbered or re-lettered to accomplish such intention; and that the word “ordinance” may be changed to “section”, “article” or other appropriate designation.

This Ordinance shall become effective immediately upon adoption.
