1. SPECIAL MEETING ELECTION

Mayor Bairstow opened the meeting and stated that there would be a recess until the results of the election came in.

Mayor Bairstow reconvened the meeting at 7:30 PM and asked the Clerk to read the results into the record.

Clerk McKamey stated that there were a total of 383 total ballots cast:
For the Office of Mayor: 241 votes for Tammy C. Moore and 139 votes for Ron Shelley;
For the Office of Commission Seat #1: 243 votes for Michael J. Goldman and 122 votes for Frederic Kurzhals.

Commissioner Chaffin made a Motion to Accept the Election Results and Commissioner Abshier seconded the Motion.

On roll call vote, YES: Nadeau, Anderson, Abshier, Chaffin, Bairstow
The Motion passed with a 5-0 vote.
