

RESOLUTION 06-16

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF BELLEVIEW, FLORIDA AMENDING THE FEE SCHEDULE FOR WATER/SEWER RATES; ESTABLISHING AN EFFECTIVE DATE TO COMMENCE WITH THE OCTOBER 2006 BILLING.

WHEREAS, the City Commission of Belleview, Florida, is authorized to establish water and sewer rates; and

WHEREAS, Ordinance 03-23 provides that water and sewer rates may be amended by Resolution duly adopted by the City Commission of Belleview, Florida; and

WHEREAS, the City Commission of Belleview, Florida, desires to increase said rates.

NOW, THEREFORE, BE IT RESOLVED that the City Commission of Belleview, Florida hereby amends Appendix B. Table 3.H. Water and Sewer Service Rates to be effective so that the new fee shall be due upon the October 2006 billing:

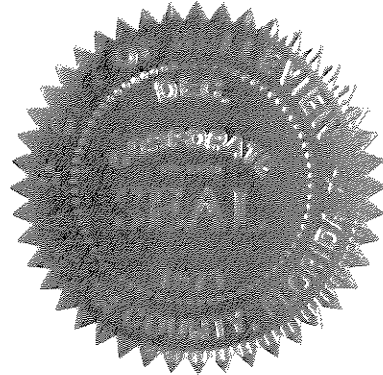
