NOTICE IS HEREBY GIVEN that the City of Belleview Commission will accept Applications and Letters of Interest to fill the unexpired term of Commissioner Gary Ernst, Commission Seat 2, until the next official Municipal Election, which will be held Tuesday, November 8, 2022. You **MUST** reside in the City of Belleview to apply for this Commission Seat Appointment.

Pursuant to the City's Charter, Article III – Section 3.02 – Qualification of members, the following are requirements to be a City Commissioner:

- Applicant must be a bona fide resident of the City of Belleview.
- Applicant must be a citizen of the State of Florida and the United States of America.
- Applicant must be a registered voter and be qualified to vote a city, state and national elections.
- Applicant must be 18 years of age or older.
- Applicant must have resided within the city limits of the City of Belleview for one (1) year immediately preceding the date of election.

Along with the application, please include a Letter of Interest with a narrative as to why you would be a good candidate for the City of Belleview Commission with any additional information you wish to share with the Commission.

Following appointment, the approved candidate will be required to file a Financial Disclosure Form in accordance with state regulations.

Completed Commission Seat Applications must be submitted to the City Clerk's Office no later than **4:00 p.m. on Monday, March 22, 2022** to be considered.

Section 3.05 - Powers vested in City Commission. The legislative powers of the city shall be vested in and exercised by the City Commission and the City Commission shall have the power to pass ordinances, adopt resolutions, approve or disapprove the appointment by the Mayor of all appointive officers, boards. All powers of the City, except as otherwise provided by this Charter or by the Constitution of the State of Florida, are hereby vested in the City Commission, and except as otherwise provided by this Charter or by the Constitution of the State of Florida, are hereby vested.
