Please initial each item and sign below:

- The LULL fee for non-profit vendors is \$25.00
- The LULL fee for commercial vendors is \$53.25. The fee includes \$50.00 + sales tax. Our sales tax as a municipality is figured at 6.5%.
- Arrival time for vendors begins at 12:00 pm. Vendors must be completely set up by 1:30 pm.
- Vendors may utilize food trucks, carts, trailers/wagons, temporary tents, or tables. Equipment/vehicles must be removed from the park when not in operation. No equipment or vehicles are to be left at the park overnight.
- Electricity spaces are limited and are provided on a first-come basis at an additional fee of \$10.00.
- Service time is 2 pm to 6 pm, with no exceptions. Packing and cleaning up are permitted if the vendor sells out prior to 6 pm. Vendor spaces must remain lit and accessible to optimize a professional look.
- Vendors must collect the proper sales tax and provide the proper state licensing for food sales and preparation.

- The vendor must provide his/her own equipment as needed to properly provide the items/services indicated.
 - The sale of tobacco products is prohibited.
 - In the performance of the permitted services, the vendor will be acting in the capacity of an "independent contractor" and not as an agent, employee, partner, joint venture, or associate of the City. The food vendor shall be solely responsible for the means, methods, techniques, sequences, and procedures utilized in the full performance of the services permitted.
 - The City of Belleview reserves the right to modify the terms of the vendor application at any time at the City's sole discretion.
