- _____ **The Foodie Fest Vendor fee is \$25.00 + sales tax of 6.5 % = \$26.63 each month and due prior to the event, space permitting.**
- _____ Arrival time for vendors is 3 pm. Set-up will begin once all trucks are in place and are completely set up by 4:30 pm.
- _____ Food vendors may utilize food trucks, carts, trailers/wagons, temporary tents, or tables. Equipment/vehicles must be removed from the park when not in operation. No equipment or vehicles are to be left at the park overnight. The City is not responsible for items or equipment left at the park.
- _____ Electricity spaces are limited and are provided on a first-come basis.
- _____ Service time is 5 pm to 9 pm, with no exceptions. Packing and cleaning up are permitted if the vendor sells out before 9 pm. Vendor spaces must remain lit and accessible to optimize a professional look.
- _____ Vendors must collect the proper sales tax and provide the proper state licensing for food sales and preparation.
- _____ The vendor must provide his/her own equipment as needed to provide the items/services indicated properly.
- _____ The sale of tobacco products is prohibited.
- _____ In the performance of the permitted services, the food vendor will be acting in the capacity of an "independent contractor" and not as an agent, employee, partner, joint venture, or associate of the City. The food vendor shall be solely responsible for the means, methods, techniques, sequences, and procedures utilized in the full performance of the services permitted.
- _____ The City of Belleview reserves the right to modify the terms of the vendor application at any time at the City's sole discretion.

I agree to indemnify the City of Belleview or anyone connected with the show and exhibit and hold them harmless against all actions, claims, liabilities, losses, costs, and expenses wthat in any way, may arise in connection with or resulting from the Foodie Fest, including claims for bodily injury or death of persons, and for loss of or property damage, whether the same is due to the negligent act of omission of this organization, their agents, employees, or otherwise.

This is a rain or shine event. There is NOT a Rain Date Scheduled. Application fees are non-refundable in all circumstances. Fees include space rental, advertisement, and processing. Vendors must be set up by 4:30 pm. All booths will remain open until 9:00 pm. Those vendors, who choose to dismantle booths and leave early, will not be invited back to Friday Foodie Fest.
