

RESOLUTION 24-05

**A RESOLUTION OF THE CITY COMMISSION OF THE
CITY OF BELLEVIEW, FLORIDA AMENDING APPENDIX
B, SECTION 5, TABLE 3.B – GARBAGE AND TRASH
COLLECTION FEES AS AUTHORIZED IN THE CITY
CODE OF ORDINANCES; AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, the City Code of the City of Bellevue authorizes an exclusive franchise for the collection of residential and small business solid waste collection and disposal; and

WHEREAS, the City advertised for a residential and small business solid waste collection and disposal hauler; and

WHEREAS, the City Commission awarded the contract for residential and small business solid waste collection and disposal to Florida Express and Environmental in the amount of \$17.42 per month per customer, inclusive of the administrative and franchise fees;

WHEREAS, the 2019 Exclusive Franchise Agreement with Florida Express Environmental, Section 34 provides that the collection rate payable to the Contractor shall be subject to adjustment, upward or downward, to reflect increases or decreases in the disposal cost charge to the Contractor.”

WHEREAS, Marion County has raised their landfill disposal fees to take place on May 1, 2024 increasing the Garbage disposal cost per account by \$.75 and the Yard Waste disposal cost per account by \$.26; and

WHEREAS, the Exclusive Franchise Agreement provides for a 10% franchise fee and 3% administrative on collection fees, including the increase provided herein; and

NOW, THEREFORE, BE IT RESOLVED that the City Commission of Bellevue, Florida hereby amends Appendix B – Fees, Section 5. - Table 3.B—Garbage and Trash Collection Fees as follows:
