Ordinance 2024-12 Special Events

1. Summary of the proposed ordinance (must include statement of the public purpose, such as serving the public health, safety, morals, and welfare):

Ordinance 2024-12 is proposed for the purpose of imposing limits on outdoor amplified sound at establishments to protect public health and safety of patrons, nearby businesses, and residences. The ordinance restricts the number of special events per parcel to no more than four times per calendar year and no more than 12 total days per calendar year. Amplified sound/music shall not be used between the hours of 7:00 p.m. and 8:00 a.m., Sunday through Thursday, and between the hours of 10:00 p.m. and 8:00 a.m. on Friday and Saturday.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City, including the following, if any:

- (a) An estimate of direct compliance costs that businesses may reasonably incur;
- (b) Any new charge or fee imposed by the proposed ordinance, or for which businesses will be financially responsible; and
- (c) An estimate of the City regulatory costs, including estimated revenues from any new charges or fees to cover such costs.

Ordinance 2024-12 does not impose any new charge or fee on businesses.

The city may incur increased, indeterminate regulatory costs associated with code compliance.

3. Good faith estimate of the number of businesses likely to be impacted by the proposed ordinance:

The city estimates that 377 private, for-profit businesses would potentially be subject to Ordinance 2024-12.
