Ordinance 2024-13 Flags Banners Pennants

This Business Impact Estimate is provided in accordance with section 166.041(4), *Florida Statutes*.  - b. Sections 190.005 and 190.046, *Florida Statutes*, regarding community development districts;
 - c. Section 553.73, *Florida Statutes*, relating to the *Florida Building Code*; or
 - d. Section 633.202, *Florida Statutes*, relating to the *Florida Fire Prevention Code*.

In accordance with the provisions of controlling law, even notwithstanding the fact that, an exemption noted above may apply, the City of Belleview hereby publishes the following information:

1. Summary of the proposed ordinance (must include statement of the public purpose, such as serving the public health, safety, morals, and welfare):

The city finds it in the public interest to provide certain standards and limitations regarding flags, flagpoles, banners and pennants.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City, including the following, if any:
 - (a) An estimate of direct compliance costs that businesses may reasonably incur;
 - (b) Any new charge or fee imposed by the proposed ordinance, or for which businesses will be financially responsible; and
 - (c) An estimate of the City regulatory costs, including estimated revenues from any new charges or fees to cover such costs.

There will likely be a direct compliance cost associate with Ordinance 2024-13. Although banners have previously been considered temporary signs, there has not been a fee, causing difficulty in compliance monitoring. In order to tract the time frames allotted for banners, a Development Services permit will be required. The cost for the permit is \$50. The fee will help cover staff time for code compliance monitoring.

3. Good faith estimate of the number of businesses likely to be impacted by the proposed ordinance:

The city estimates that 377 private, for-profit businesses would potentially be subject to Ordinance 2024-13.

4. Additional information the governing body deems useful (if any):

Ordinance 2024-13 amends Section 126-6 of the sign code as a result of a request by local businesses during a regularly scheduled City of Bellevue Commission Meeting. This ordinance will apply to all commercial properties, multi-family, and single-family properties in the city and therefore, the proposed ordinance does not affect only businesses.
