

RESOLUTION 24-20

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF BELLEVUE, FLORIDA, APPROVING AND ADOPTING THE MARION COUNTY EMERGENCY MANAGEMENT PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 252.35(2) Florida Statutes, authorizes and empowers the State Division of Emergency Management (hereafter the "Division") to promulgate rules and regulations to carry out the provisions of the State Emergency Management Act; and

WHEREAS, Marion County, in compliance with the above requirements, has revised the Comprehensive Emergency Management Plan, which has been reviewed and approved by the Division; and

WHEREAS, Section 27P-6.0023, Florida Administrative Code further requires that the governing body of Marion County adopt by resolution, the Marion County Comprehensive Emergency Management Plan; and

WHEREAS, the Board of County Commissioners of Marion County has approved and adopted the Comprehensive Emergency Management Plan at their August 20, 2024 meeting; and

WHEREAS, in times of emergency the City of Bellevue participates in Marion County's Comprehensive Emergency Management Plan; and

WHEREAS, the City Commission of the City of Bellevue has reviewed the revised Marion County Comprehensive Emergency Management Plan and finds that said plan meets the needs of the City; and

WHEREAS, the City Commission of the City of Bellevue finds that adopting the Marion County Emergency Management Plan will promote the health, safety, and welfare of the citizens of Bellevue.


NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Bellevue, Florida that:

Section 1: The Comprehensive Emergency Management Plan, adopted by Marion County and incorporated herein by reference, is hereby approved and adopted by the City of Bellevue as its Comprehensive Emergency Management Plan.


BE IT FURTHER RESOLVED that this Resolution shall take effect immediately upon adoption by the City Commission of the City of Bellevue, Florida.




