- other public areas. The owners of such facilities, or their successors or assigns, shall be responsible for maintaining such facilities in good and safe repair
- E. Issuance of this permit does not authorize removal of any trees from within the City right-of-way for utility installations. Prior approval must be obtained from the Public Works Director.
  - F. Issuance of this permit does not allow cutting of the pavement nor cutting of private driveways within the right-of-ways.
  - G. If construction involves underground work near city utility lines, this work must take place during normal city operating hours of 7am-6pm, Monday-Thursday.
  - H. This application shall become a permit with signature of authorization below.

You must notify the Public Works Department 48 hours prior to commencement of this proposed construction. (352-245-7021, ext 2115)
