- A. All authorized work shall be completed in accordance with this approved application, the provisions of the Public Works Manual, and other applicable regulations.
- B. Public safety shall be maintained during the construction in accordance with the provisions of section 6 of the Manual of Uniform Traffic Control Devices.
- C. When excavation is included in this permit, all utility companies must be consulted for information as to existing pipelines and appurtenances pursuant to the provisions of Chapter 533.851 of the Florida Statutes
- D. Private driveways, public utilities, and other such improvements permitted herewith which are not available for immediate use by the general public are considered as remaining in private ownership and accommodated within the public right-of-way or

other public areas. The owners of such facilities, or their successors or assigns, shall be responsible for maintaining such facilities in good and safe repair

- E. Issuance of this permit does not authorize removal of any trees from within the City right-of-way for utility installations. Prior approval must be obtained from the Public Works Director.
- F. Issuance of this permit does not allow cutting of the pavement nor cutting of private driveways within the right-of-ways.
- G. If construction involves underground work near city utility lines, this work must take place during normal city operating hours of 7am-5:30pm, Monday-Thursday.
- H. This application shall become a permit with signature of authorization below.

You must notify the Public Works Department 48 hours prior to commencement of this proposed construction. (352-245-7021, ext. 2115)
